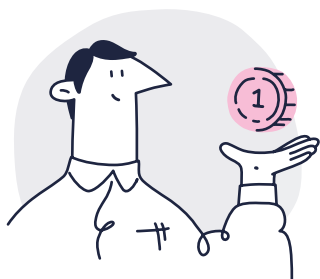

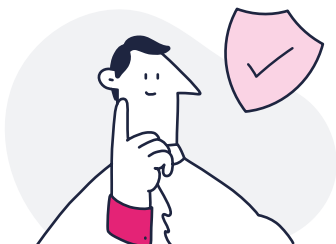

The key features of WPS include:

All employers registered with the MOHRE must transfer salaries through WPS.



Payment Mechanism:

Salaries are transferred via approved banks, exchange houses, and financial institutions, ensuring secure and traceable transactions.



Monitoring and Enforcement:

MOHRE monitors compliance and takes action against non-compliant employers, including penalties and restrictions on new work permits.



Benefits for Employers:

Enhances employer reputation, reduces labor disputes, and ensures compliance with UAE labor laws.
